9. Correspondence

• Email from Leslie Short (Artisan Planning and Property Services), acting on behalf of the developer and landowner of the Friends Garage site. This was discussed at the Parish Council meeting last week, after a letter and possible plan for the site were sent by Artisan to every house in Orford. Those involved with the Friends of Orford Community Interest Company (CIC) had put together a response to this which would be delivered to every house in Orford over the next few days, saying that the suggested plan from Artisan had not been put together in conjunction with the CIC or the Parish Council. Members of the CIC would be meeting very soon and already had an alternative plan in hand for the commercial element of the site. The CIC will then be in touch with the Parish Council to seek input and approval about their proposals. The current proposal from Artisan poses a number of problems (a commercial element which appears to be two separate buildings and is not big enough to be viable, a layout which may well not be acceptable to Suffolk County Council Highways etc).
